The method of payment will be either by crossed bank cheque to the order of the Wastewater Management Authority or by cash.

Bids duly filled in and contained in a sealed envelope marked “**WMA/OAB/398W – Supply, installation, testing and commissioning of Generator Set, and Accessories at Malherbes 1 Pumping Station**” should be addressed to the Ag. General Manager, Wastewater Management Authority and shall be deposited in the **Tender Box**, on the 6th floor at the address below at or before **13.00 hrs** (local time) on **Monday 05 November 2018**. **Late Bids will be rejected**. Bids will be opened physically in the presence of the
