1. Scope of Contract

The Wastewater Management Authority (WMA), on behalf of the Ministry of Energy and Public Utilities (MEPU), invited sealed bids through Open Advertised Bidding for Contract WW389W – Sewerage Project at Valentina, Phoenix

- Topographical surveys, detailed design and submission for WMA's approval

- Excavation and laying of about 750 m of uPVC 200 mm diameter pipes
