The WMA intends to upgrade the Sewer Line along J. Nehru Street - Phase II (From Junction Edgar Quirin Road to Junction S. Hossen Avenue/A10 Road)

The objective of the project will be to provide proper sewerage facilities to the residents of the locality and thereby minimizing the health hazards being caused by frequent overflow and malfunctioning of the current sewer network.

The WMA initiated a first phase of the project which concerns the stretch from junction St Paul Road and J. Nehru to junction J. Nehru and Edgar Quirin Road. The Works were completed in July 2019.
