

Executive Summary of Bid Evaluation Report

1.0 Project Title: Rehabilitation/Provision of Sewerage Infrastructure at Residence Vallée des Prêtres and Bernardin de St Pierre Road – CHA IV (Contract No. WW 491W)

2.0 Reference number of procurement: WMA/IFB/2022/751; OAB/12/2022

3.0 Scope of Contract:

The scope of works for the two sites considered under the Contract, is as follows:

A. Residence Vallée des Prêtres

- Rehabilitation/upgrading of the existing street sewers of approximately 1 km and all associated service corridor sewers
- Reconnection of 220 Nos. inside Residence Vallée des Prêtres.

B. Bernardin de St Pierre Road (from junction School lane to Kenda Lane)

- Rehabilitation/upgrading of the existing main sewer of approximate length of 700 m with 250 mm uPVC pipe
- Re-connection (from ICA to the new 250 mm uPVC pipe) of the lateral connections
- Connection of around 60 houses.

The Works will comprise inter alia the following:

- Design and submission of Design Report with revised Bill of Quantities for WMA's approval
- Production of construction drawings
- Construction of new sewer lines
- Decommissioning of existing sewer lines and manholes, if any
- Asphaltic reinstatement works of roads, both temporary trench width and permanent full width resurfacing
- Provision/Rehabilitation of individual house connections, if any
- Decommissioning of existing house connections, wherever applicable
- Decommissioning of existing cesspits and backfilling of same, if any and wherever applicable
- Reinstatement works within private premises
- Protection of existing services such as underground telecom lines, water pipes, etc..
- Design and construction of water works, wherever applicable
- Raising of existing manholes, if any

- Rivers/canal/ drain crossings, if any
- Refurbishment works to sewer appurtenances, if any, as may be directed.

4.0 Procurement method used: Open National Bidding

5.0 Date of Invitation for Bids: Advertisement of the Invitation for Bids were published in the Local Press and uploaded on the PPO E-Procurement System on 12 April 2022.

6.0 Closing date for submission of Bids: The closing date for the submission of Bids online on the E-Procurement System was fixed for 11 May 2022 up to 13:29 hours at latest (local time).

7.0 Date and place of openings of Bids: Bids were opened online on 13 May 2022 as from 13:30 hours at latest (local time) in the Conference Room at the WMA.
